10 **City Support for Mt. Olive Neighborhood BusinessWorks Program**

12 **FOR** the purpose of demonstrating the City of Annapolis' support for Maryland  
13 Department of Housing and Community Development, Neighborhood  
14 BusinessWorks Program financing to the Mt. Olive Community Life Center.

16 **WHEREAS,** the City of Annapolis is interested in promoting the revitalization of our  
17 community by encouraging the development and/or expansion of for-profit  
18 and nonprofit small businesses; and

20 **WHEREAS,** the Mount Olive Community Development Corporation applied to the  
21 Neighborhood BusinessWorks Program for financing to acquire and  
22 renovate a building to house a community center located at 8 Dorsey  
23 Avenue, Annapolis, Maryland 21401; and

25 **WHEREAS,** this project is located in a State-approved locally designated revitalization  
26 area known as "Parole Neighborhood" and conforms to the local zoning  
27 code; and

29 **WHEREAS,** the regulations of the Neighborhood BusinessWorks Program require that  
30 all projects receiving financing be approved and supported by the  
31 appropriate governing body of the locality in which the project is situated.

33 **NOW THEREFORE BE IT RESOLVED BY THE ANNAPOLIS CITY COUNCIL** that  
34 that the City of Annapolis hereby endorses the Neighborhood BusinessWorks Program  
35 financing to Mount Olive Community Development Corporation; and
