

# Daily Report 10/24/13

**In the last 24 hours Annapolis Police officers responded to 108 calls for service and arrested 12 people.**

**Good News** – In separate incidents Derwyn Spriggs, 26, of Annapolis and Robert Bell III, 23, of Brooklyn, were arrested on warrants for weapon violations. The charges on Spriggs and Bell stem from two separate incidents when officers stopped them for traffic violations and handguns were found in the vehicles. On 10/22 Spriggs was arrested on the warrant for CDS possession with intent to distribute, CDS possession marijuana, three counts of CDS paraphernalia, possession of a firearm during a drug trafficking crime, and handgun in vehicle. Spriggs is being held at the Jennifer Road Detention Center on \$100,000 bond. On 10/23 Bell was arrested on the warrant for two counts of possession of a firearm by a convicted felon, illegal possession of ammunition, two counts of handgun in vehicle, and two counts of handgun on person. Bell is being held without bond at the Baltimore City Detention Center.

**Theft from Vehicle** – 201300005129 – 700 block of Bay Ridge Av – 10/22 at 1pm to 10/23 at 7:40am: The passenger side window was broken and a brown Camelback backpack, and a bag containing clothing and a pair of boots were stolen from the front passenger seat of the vehicle. The bag, clothing, and boots were later recovered in the 800 block of Bay Ridge Av. The bag had broken vehicle glass inside and was found inside a recycling bin.

**Theft from Vehicle** – 201300005135 – 1000 block of Madison St – 10/22 at 4pm to 10/23 at 12:15pm: A vehicle's battery was stolen. The vehicle has a small side window missing allowing access to the interior of the vehicle to open the hood.

**Theft from Vehicle** – 201300005138 – 1700 block of Forest Dr – 10/16 from 2pm to 2:30pm: Money and a visitor parking pass were stolen from a vehicle which was left with a window rolled down.

## **National Takeback Initiative**

The 7<sup>th</sup> Annual National Takeback Initiative will be held on Saturday, October 26, 2013 from 10am to 2pm. The National Takeback Initiative is a safe way to get rid of unwanted and expired medication. It will be held in the lobby of the Annapolis Police Department at 199 Taylor Avenue.

It is completely anonymous, no identification is requested of people disposing of prescription medications, and people are therefore encouraged to remove identifying labels from containers. Liquid medications should be in a sealed container to prevent leakage (ziplock bag). Other medications will be disposed of directly into the disposal box, and their original containers can be put in a recycling bin. We are NOT accepting needles or injectibles. Any other type of medication is accepted (controlled, non-controlled, or over the counter).
