## 2013 Annapolis Election Calendar

This calendar has been prepared by the City Clerk for the Board of Supervisors of Election for the 2009 Municipal Election. The reference to the "Code" is to the Annapolis City Code, not the State Election Code. For the provision in the Code on the computation of time, see the last page of this calendar.

### Election Cycle

Wednesday, November 4, 2009 - Tuesday, November 5, 2013

*Code Sec. 4.04.010 Definitions*

"Election cycle" means that period of time beginning on the day after the day of a general election and ending on the day of the next general election.

### March 2010

Monday, March 8, 2010

- Members of the board of supervisors of elections shall be appointed by the City Council on the second Monday of March every four (4) years, beginning in 1986.

*Charter, Art. II, Sec. 6(b)*

Members of the Board of Supervisors of Elections shall be appointed by the City Council for a term that begins on the second Monday of March following the General City Election in the preceding November and ends four years later on the second Monday in March. In the event of a vacancy, the City Council shall immediately fill the vacancy only for the remainder of the four year term. A member must be reappointed for a new term in order to serve beyond any four year term. A chair of the Board of Supervisors of Elections shall be chosen annually by its members.

### November 2011

Friday, November 4, 2011

- Deadline for being registered to vote in the City for mayoralty candidates.

*Charter, Art. II, Sec. 3(b)*

The mayor must be a registered voter in the city for at least two (2) years immediately preceding the date of the general election. A person may not hold office as mayor for more than two (2) full consecutive terms to which elected in the manner provided by City Code.

Note: The provision in the Code in computing time applies only to the Code and not to the Charter. See *Code Sec. 4.04.020*

### November 2012

Monday, November 5, 2012

- Deadline for being registered to vote in the City for aldermanic candidates.

*Charter, Art. II, Sec 3 (c)*

Aldermen, except those first elected from areas annexed to the city, shall be registered voters in the city for at least one (1) year immediately preceding their election and a registered voter in the ward from which they are elected for at least six months and must have resided in that ward for at least six (6) months immediately preceding the date of the general election.

Note: The provision in the Code on the computation of time only applies to the Code and not to the Charter. See Code Sec. 4.04.020

## June 2013

Tuesday, June 18, 2013

- Deadline for changing polling places

*Code Sec. 4.08110 B*

Except in emergencies a new polling place may not be designated, nor may the location of an existing polling place be changed, after the Tuesday which is thirteen weeks prior to any primary election. Where possible and feasible, the polling places utilized for the immediately preceding presidential election shall be used.

## August 2013

Monday, August 5, 2013

- Deadline for filing certificate of candidacy, except for write-in candidates.

*Code Sec. 4.20.030 B*

Except for certificates of candidacy filed by write-in candidates and as otherwise provided in this chapter, certificates of candidacy shall be received and filed in the office of the board not later than nine p.m. on the Monday which is seven weeks before the day on which the primary election should be held under the primary election law. If the filing date should occur on a legal holiday, the certificates must be received and filed not later than nine p.m. on the next regular business day which is not a legal holiday.

*Code Sec. 4.20.090 B*

A candidate for public office seeking nomination by petition shall file a certificate of candidacy at the time and place and in the manner provided in this chapter and shall comply with all other applicable provisions of this title, in the same manner as candidates for nomination at a primary election.

*Code Sec. 4.08.080 C*

The Offices of the Board shall be open from nine a.m. to nine p.m. on the last day for the filing of a certificate of candidacy.

Monday, August 5, 2013

- Deadline for filing petition for nomination by petition

*Code Sec. 4.20.100 A*

The entire petition shall be filed with the board at the time of the filing of the certificate of candidacy.

- Deadline for Council to certify ballot questions to the Board

*Code Sec. 4.40.010 A*

Whenever a proposed Charter amendment or other question is to be submitted for popular approval to the voters of the City or to the voters of any area proposed to be annexed to the City, the City Council shall certify the question to the board on or before the day on which a certificate of candidacy must be filed under this title.

Monday, August 12, 2013

- Deadline for withdrawing as candidate for nomination

*Code Sec. 4.20.150 B 1*

Whenever any person who has filed a certificate of candidacy for nomination in any primary election, in a writing signed by the person withdrawing, and acknowledged before a notary public or any other person empowered to take oaths, notifies the board within seven days after the filing date established in this chapter that the person desires to withdraw as a candidate for such nomination, the certificate of candidacy shall be void. The name of the person so withdrawing shall not be printed upon the ballots to be used at the primary election. The filing of a valid certificate of withdrawal of candidacy is a final act of withdrawal; and a person who files such a certificate of withdrawal may not reinstate the person's candidacy, unless the time limit for the filing of candidacies has not expired.

*Code Sec. 4.20.150 B 2*

A certificate of withdrawal of candidacy shall be accepted until four-thirty on the last day for withdrawing.

A person may not vote in a municipal election if the person registers after the fifth Monday preceding the election.

*Code Sec. 4.16.040 B.*

A notification of change of address or name, or request for party designation or change in party affiliation, received by the Board of Supervisors of Elections of the County after the fifth Monday preceding a municipal election is not effective for that election.

Tuesday, August 13, 2013

- Deadline for posting of ballot

*Code Sec. 4.24.070 B*

No less than twenty-five days before any election, the form and arrangement of all ballots to be used in the election, showing the offices, names of candidates, charter amendments and questions, shall be prepared by the board and made available for inspection by any registered voter. Following five days of public display, a court may not entertain a suit or grant injunctive relief to any party seeking to challenge the form or arrangement of the ballots or the wording of a charter amendment or question on a ballot. If the ballot titles of charter amendments and questions are certified prior to twenty-five days before the election, they shall be made available for inspection by any registered voter.

Monday, August 19, 2013

- End of Ballot Posting
- Deadline for voter registration for primary. The Board's office will be open from 9:00 A.M. to 9:00 P.M.
- Deadline for central committee to fill vacancy resulting from failure of any candidate of party to file

*Code Sec. 4.20.040 B*

In case of any vacancy which may exist in respect to a candidate for any officer elected by the voters by reason of there being no candidate of a political party to file for the same in the primary election, the central committee authorized to fill such vacancy shall file the certificate of nomination with the board not later than the fifth day after the date on which candidates may withdraw their candidacy before the primary election.

Tuesday, August 20, 2013

- Deadline for appointment of election judges

*Code Sec. 4.08.050 D.*

The judges shall be appointed not later than the Tuesday which is four weeks prior to any city primary election. Unless excused for good cause by the board, they shall be bound to serve in the position until the Tuesday which is four weeks prior to the next city primary election.

- Deadline for first campaign finance report

*Code Sec. 4.44.080 A(1)*

A candidate to public or party office, and the treasurer designated by that candidate shall file and sign the report or statement of contributions, loans and expenditures as prescribed in accordance with this chapter with the board. Election reports as specified below are required by all candidates for public or party office, whether or not the candidate's name appears on the primary ballot, the candidate withdraws subsequent to filing the candidate's certificate of candidacy or the candidate is unsuccessful in the election. Each report filed shall contain all contributions received and expenditures made in furtherance of the candidate's nomination or election by the candidate personally or, with the knowledge of the candidate, by any other person or groups of persons. The report shall be completed, except as otherwise provided in this section, through and including the Sunday immediately preceding the day by which that report is to be filed. The initial report filed shall contain all contributions and loans received and expenditures made since the date of the last preceding election to fill the office for which the person is a candidate. Each subsequent report shall contain all contributions and loans received and expenditures made since the end of the period for which the last preceding report was filed. A statement to that effect must be included on the forms prescribed pursuant to this chapter. The reports shall be filed as follows:

1. No later than the fourth Tuesday preceding any primary election;

Tuesday, August 27, 2013

- Report on party registration

*Code Sec. 4.16.050 Reports of Registration.*

Within fifteen days after the commencement of the five-week period before a primary election in which voters already registered are not allowed to affiliate with a party or change party affiliation for purposes of this chapter, the board shall prepare a report of registration setting forth the following information, as shown on the books of the board as of the date of the commencement of the five-week period:

- A. The name of each political party with which one or more registered voters in the City are then affiliated; and
- B. The total number of registered voters affiliated with each such political party.

## September 2013

Tuesday, September 10, 2013

- Deadline for applying for registration list

*Code Sec. 4.16.090*

Requests for copies of current registrations shall be referred to the Anne Arundel County Board of Elections, 7320 Ritchie Highway, 2nd Floor, Glen Burnie, Maryland 21061 or by Email @ elections@aacounty.org

Notes: The provision in the Code on the computation of time only applies to the Code and not to the Charter. See *Code Sec. 4.04.020*

Tuesday, September 10, 2013

- Deadline for receipt of application for regular absentee ballot

*Code Sec. 4.28.040*

Except for persons who become eligible to cast an emergency absentee ballot, a qualified voter desiring to vote at any election as an absentee voter shall make application in writing to the board for an absentee ballot, and the application must be received not later than the close of business Tuesday preceding the election.

- Deadline for second campaign finance report

*Code Sec. 4.44.080 A (2)*

No later than the Tuesday immediately preceding any primary election;

Wednesday, September 11 - Tuesday, September 17

- Deadline for application for emergency absentee ballot

*Code Sec. 4.28.030 A*

After the Tuesday preceding an election and on the day of the election prior to the time the polls close, any person registered and otherwise qualified to vote may apply for an emergency absentee ballot if the person is notified after the time for making application for an absentee ballot that, as a condition of employment, the person is required to be absent from the City on the day of an election, if the person is one described in Section 4.28.010(A), if the person is unable to be physically present at the polls as a result of illness or accident occurring after the time of making application for an absentee ballot, or if the person is unable to be present because of a death or serious illness in the person's immediate family occurring after the time for making application.

Friday, September 13 - Monday, September 16

- Publication of election notice in newspaper

*Code Sec. 4.08.090*

Except as otherwise provided by law, the board shall publish, for all elections, for two consecutive days prior to each election, in one or more newspapers of general circulation within the City, the time and place and names of the candidates for nomination, or for members of central committees of a political party. The list of nominations published by the board shall be arranged to the extent practicable, in the order and form in which they are to be printed upon the ballots. In the discretion of the board, notice may also be given by handbills set up in those public places in each precinct as the board determines.

Tuesday, September 17, 2013

- Primary Election Day (Third Tuesday of September) The Board's office will be open from 5:45 A.M. to 9:00 P.M.

*Code Sec. 4.24.020 Hours for voting.*

The polling places throughout the City shall be opened by the judges at seven a.m. on the day of election and the polling places shall remain open until eight p.m. on the same day, when the polling places shall be closed.

*Code Sec. 4.24.190(A)*

The polls shall be officially closed at eight p.m., except that all qualified voters who are then waiting in line to vote shall be permitted to do so by the judges.

*Code Sec. 4.08.080 Office hours on certain days.*

The Office of the Election Board shall be open on Election Day no later than seven a.m. and close no earlier than eight p.m., and the members of the board shall be available when needed on such day.

Wednesday, September 11 -Tuesday, September 17

- Deadline for receipt by Board of absentee ballots, including emergency absentee ballots, but excluding ballots which are mailed

*Code Sec. 4.28.030 (A) Emergency ballot.*

After the Tuesday preceding an election and on the day of the election prior to the time the polls close, any person registered and otherwise qualified to vote may apply for an emergency absentee ballot if the person is notified after the time for making application for an absentee ballot that, as a condition of employment, the person is required to be absent from the City on the day of an election, if the person is one described in Section 4.28.010(A), if the person is unable to be physically present at the polls as a result of illness or an accident occurring after the time of making application for an absentee ballot, or if the person is unable to be present because of a death or serious illness in the person's immediate family occurring after the time for making application.

*Code Sec. 4.28.100 C (1)*

A ballot shall be considered as received timely, provided:

- a. It has been received by the board prior to the closing of the polls on Election Day; or
- b. It was mailed before Election Day, the United States Postal Service, or postal service of any other country, has provided verification of that fact by affixing a mark so indicating on the covering envelope, and the board receives the ballot from the United States Postal Service not later than the close of business on the Wednesday following election day.

Wednesday, September 18

- Deadline for receipt by the Board of absentee ballots which have been mailed by the day before the election

*Code Sec. 4.28.100 C (1 b)*

Timeliness of absentee ballots:

1. A ballot shall be considered as received timely, provided:

- a. It has been received by the board prior to the closing of the polls on Election Day; or
- b. It was mailed before Election Day, the United States Postal Service, or postal service of any other country has provided verification of that fact by affixing a mark so indicating on the covering envelope, and the board receives the ballot from the United States Postal Service not later than the close of business on the Wednesday following election day.

Thursday, September 19

- Board of Canvass conducts canvass

On the Thursday following every election, the Board of Elections shall be reconstituted as the Board of Canvassers. Each member of the Board of Canvassers shall recite an oath, under the penalty of perjury, to truly canvass, add up

and declare the votes as required by law. The Board of Canvassers has the same powers as the Board of Supervisors of Elections.

Note: The Primary Election Canvass (*Location To Be Determined*)

Monday, September 23

- Deadline for transmitting statement of returns to City Council And Clerk Of The Circuit Court

*Code Sec. 4.32.050 A Certified returns--Transmission for record.*

Within forty-eight hours after the completion of the canvass, the Board of Canvassers shall transmit one of each of the statements made by it, attested by the signature of its chair and secretary, to the City Council and to the Clerk of the Circuit Court for Anne Arundel County, who shall enter the same of record.

Thursday, September 26

- Deadline for removal of campaign signs by defeated candidates

*Code Sec. 4.48.170 E*

Any election campaign sign which has been erected or posted shall be removed within seven days after the election to which the sign was applicable.

Friday, September 27

- Deadline for declining nomination.

*Code Sec. 4.20.150 C (1) and (2)*

(1) Any person nominated for Mayor or Alderman may decline such nomination by notifying the board that the nomination is declined. The statement of declination shall be in writing, signed by the person nominated and acknowledged before a notary public or any person empowered to take oaths, and shall be filed with the board within ten days after the date of the primary election. If the person nominated complies with the provisions of this subdivision for declining nomination, the nomination shall be void; and the name of any person so withdrawing shall not be printed upon the ballots.

(2) A certificate of declination of candidacy shall be accepted until four-thirty p.m., on the last day for declining.

- Deadline for petitioning for recount in primary election

*Code Sec. 4.20.190 Recount--Petition deadline.*

Within ten days after the day of any primary election, or within two days after the results of the canvass are declared official, any candidate for a nomination or for member of a central committee who has been defeated on the face of the returns, may petition the board for an appeal from and review of the action and decision of the judges in counting the ballots, and for a re-canvass and recount of the ballots cast in any or all of the precincts of the City.

Note: Should the declaration of the results of the canvass be delayed to within two days of the above deadline or beyond, the deadline for filing a recount petition is within two days of the declaration of the results of the canvass.  
*Code Sec. 4.20.190.*

## October 2013

Friday, October 4 (time adjusted computations)

- Deadline for filling vacancy in nomination

*Code Sec. 4.20.160 A*

Vacancies in nomination may be filled by the central committee of the political party to which the nominee belongs. The person filling the vacancy shall satisfy the requirements of Section 4.20.010. In the event of any vacancy

occurring because of the declination, disqualification or death of any person nominated, or because of a tie vote in any primary election, except as provided in this section, the vacancy shall be filled at least thirty days before the election. Where the vacancy results from a tie vote, the nominee selected to fill the vacancy shall be one of the candidates receiving the tie vote.

Monday, October 7

- Deadline for voter registration. The Board's office will be open from 9:00 A.M. to 9:00 P.M.

*Code Sec. 4.16.040 A*

A person may not vote in a municipal election if the person registers after the fifth Monday preceding the election.

*Code Sec. 4.08.080 B*

The Offices of the Board shall be opened from nine a.m. to nine p.m. on the fifth Monday prior to any election to provide for voter registration and to receive registration by mail applications. Registrars shall permit all qualified persons who, at the official closing time of nine p.m., are waiting to register to do so.

- Deadline for change of address or name, request for party designation, or change of party affiliation

*Code Sec. 4.16.040 B*

A notification of change of address or name, or request for party designation or change in party affiliation, received by the Board of Supervisors of Elections of the County after the fifth Monday preceding a municipal election is not effective for that election.

Tuesday, October 8

Deadline for third campaign finance report

*Code Sec. 4.44.080 A (3)*

No later than the fourth Tuesday preceding any general election;

Thursday, October 10 thru Thursday, October 17

- Deadline for posting ballot for five days of public inspection

*Code Sec. 4.24.070 (B)*

No less than twenty-five days before any election, the form and arrangement of all ballots to be used in the election, showing the offices, names of candidates, charter amendments and questions, shall be prepared by the board and made available for inspection by any registered voter. Following five days of public display, a court may not entertain a suit or grant injunctive relief to any party seeking to challenge the form or arrangement of the ballots or the wording of a charter amendment or question on a ballot. If the ballot titles of charter amendments and questions are certified prior to twenty-five days before the election, they shall be made available for inspection by any registered voter.

Friday, October 14 (time adjusted computations)

- Deadline for application of voter list

*Code Sec. 4.16.090 Copies of registration lists.*

Requests for copies of current registrations shall be referred to the Anne Arundel County Board of Elections, 7320 Ritchie Highway, 2nd Floor, Glen Burnie, Maryland 21061 or by Email @elections@aacounty.org

Tuesday, October 29

- Deadline for receipt of application for regular absentee ballot

*Code Sec. 4.28.040*

Except for persons who become eligible to cast an emergency absentee ballot, a qualified voter desiring to vote at any election as an absentee voter shall make application in writing to the board for an absentee ballot, and the application must be received not later than the close of business Tuesday preceding the election.

*Code Sec. 4.28.020 A*

Any registered voter whose physical disability, illness or accident that are serious in nature to cause confinement, will prevent the voter from being present and personally voting at the polls on any election day also is entitled to vote as an absentee voter under this chapter. The voter shall make application for an absentee ballot as provided in this chapter. The application shall be filed in the office of the board not later than the close of business of the Tuesday preceding any election. Upon receipt of the application, the board shall mail an absentee ballot to the voter entitled to the ballot. In all other respects, absentee voting as provided for in this section shall be similar to and controlled by the applicable procedure provided by law for absentee voting.

Tuesday, October 29

- Deadline for fourth campaign finance report

*Code Sec. 4.44.080 A*

No later than the Tuesday immediately preceding any general election;

**October / November 2013**

Wednesday, October 30 - Tuesday, November 5

- Deadline for application for emergency absentee ballot

*Code Sec. 4.28.030*

After the Tuesday preceding an election and on the day of the election prior to the time the polls close, any person registered and otherwise qualified to vote may apply for an emergency absentee ballot if the person is notified after the time for making application for an absentee ballot that, as a condition of employment, the person is required to be absent from the City on the day of an election, if the person is one described in Section 4.28.010(A), if the person is unable to be physically present at the polls as a result of illness or an accident occurring after the time of making application for an absentee ballot, or if the person is unable to be present because of a death or serious illness in the person's immediate family occurring after the time for making application.

Thursday, October 31 - Friday, November 1

- Publication of election notice

*Code Sec. 4.08.090*

Except as otherwise provided by law, the board shall publish, for all elections, for two consecutive days prior to each election, in one or more newspapers of general circulation within the City, the time and place and names of the candidates for nomination, or for members of central committees of a political party. The list of nominations published by the board shall be arranged to the extent practicable, in the order and form in which they are to be printed upon the ballots. In the discretion of the board, notice may also be given by handbills set up in those public places in each precinct as the board determines.

*Code Sec. 4.40.080A*

To the extent not otherwise provided by State law, the board shall advertise the title and a concise statement, prepared by the City Attorney, of every question to be submitted for approval of the voters at the same time and in the same manner as is required for the election of candidates at the general election (if applicable).

**November 2013**

Wednesday, October 30 - Tuesday, November 5

- Deadline for application for emergency absentee ballot

*Code Sec. 4.28.030 A*

After the Tuesday preceding an election and on the day of the election prior to the time the polls close, any person registered and otherwise qualified to vote may apply for an emergency absentee ballot if the person is notified after the time for making application for an absentee ballot that, as a condition of employment, the person is required to be absent from the City on the day of an election, if the person is one described in Section 4.28.010(A), if the person is unable to be physically present at the polls as a result of illness or an accident occurring after the time of making application for an absentee ballot, or if the person is unable to be present because of a death or serious illness in the person's immediate family occurring after the time for making application.

- Deadline for receipt by Board of absentee ballots

*Code Sec. 4.28.030 F*

Any emergency absentee ballot received by the board after the time for closing of the polls may not be counted.

Tuesday, November 5 (Board's office will be open from 5:45 A.M. to 9:00 P.M.)

- General Election Day

*City Charter, Art. II, Sec. 2*

The citizens and residents of the City of Annapolis qualified to vote for members of the General Assembly of Maryland, and otherwise qualified by the registration and election laws for such cases made and provided, shall elect by ballot, every four (4) years, beginning in 1985, on the first Tuesday after the first Monday in November, a mayor; and the qualified voters, in each ward shall at the same time elect by ballot one (1) resident of the ward as alderman.

*Code Sec. 4.24.020*

Wednesday, November 6

"Election cycle" means that period of time beginning on the day after the day of a general election and ending on the day of the next general election.

- Deadline for receipt by Board of absentee ballots mailed by day before election

*Code Sec. 4.28.100 C 1(b)*

Ballots mailed before Election Day, the United States Postal Service, or postal service of any other country has provided verification of that fact by affixing a mark so indicating on the covering envelope, and the board receives the ballot from the United States Postal Service not later than the close of business on the Wednesday following election day.

On the Thursday following every election, the Board of Elections shall be reconstituted as the Board of Canvassers. **A ORDINANCE** concerning

**Election Ward Boundaries**

**FOR** the purpose of altering the eight election wards of the City of Annapolis; and all matters generally relating to said wards.

**BY** repealing and re-enacting with amendments the following portions of the Code of the City of Annapolis, 2011 Edition  
Chapter 1.16

**WHEREAS,** Article II, Section 1 of the Charter of the City of Annapolis states that, "the city shall be divided by ordinance into eight (8) wards of approximately equal proportion."

**WHEREAS,** Article III, Section 2 of the Charter of the City of Annapolis states that the City Council has the power to, "...divide the city into election districts, define their bounds and limits, and correct the same from time to time, so as to preserve as accurately as may be an equal number of inhabitants in each of said districts..."

**WHEREAS,** since the 1970 federal census, the City Council has sought citizen assistance with reevaluating the boundaries of its wards; and

**WHEREAS,** the last time the City of Annapolis conducted redistricting activities was in 2001 after the 2000 United States census data was released; and

**WHEREAS,** as a result of the 2010 Census, it necessary to adjust the boundaries of the aldermanic wards in the City so that the eight wards will be composed of approximately equal population; and

**WHEREAS,** Resolution R-2-11 established the Annapolis Ward Redistricting Commission; and this matter was referred to the Annapolis Ward Redistricting Commission for their recommendations; and

**WHEREAS,** the Annapolis Ward Redistricting Commission provided their final report with their recommendations for realignment of the various wards to the Annapolis City

4 **SECTION I: BE IT ESTABLISHED AND ORDAINED BY THE ANNAPOLIS CITY**  
5 **COUNCIL** that the Code of the City of Annapolis shall be amended to read as follows:

6  
7 **CHAPTER 1.16 – ELECTION WARDS**

8 **1.16.010 - Division of City.**

9 The City shall be laid off and divided into eight wards, the boundaries of which are shown by  
10 description and on a map on file in the office of the City Clerk. The descriptions of the ward  
11 boundaries are as set out in this chapter.

12  
13 **1.16.020 - First ward.**

14 The Ffirst Wward is as follows:

15 Beginning at the junction of the centerline of Taylor Avenue and the abandoned WB&A Railroad  
16 bed, with the point so fixed; thence running with the centerline of the abandoned railroad bed  
17 and its extension running in an easterly direction to the centerline of Calvert Street; thence  
18 northerly along the centerline of Calvert Street northeasterly to its intersection with the  
19 centerline of the northwest bound lane of Rowe Boulevard (also known as Bladen Boulevard  
20 and a Bladen Street); thence northwesterly along the northwest bound lane of Rowe Boulevard  
21 to its intersection with JUNCTION OF THE CENTERLINE OF THE NORTHBOUND LANE OF  
22 BLADEN STREET (AKA, ROWE BOULEVARD, BLADEN BOULEVARD) AND the centerline of  
23 College Creek; thence following the centerline of College Creek generally northeasterly to its  
24 intersection with the Annapolis and Anne Arundel County boundary line in the Severn River;  
25 thence following the Annapolis and Anne Arundel County line southeasterly to its point of  
26 intersection with the extended centerline of Spa Creek; thence following the centerline of Spa  
27 Creek generally westerly to intersect the extended centerline of the south fork of Spa Creek  
28 between "Truxtun Heights" and "Truxtun Park" AND WEST FORK OF SPA CREEK BETWEEN  
29 "TRUXTUN HEIGHTS" AND "SPA VIEW HEIGHTS"; THENCE, FOLLOWING THE CENTER  
30 LINE OF THE WEST FORK OF SPA CREEK TO ITS INTERSECTION WITH TAX MAP 51F,  
31 PARCEL 858, THENCE WITH THE HIGH WATER LINE OF THE SOUTHERN SIDE OF THE  
32 WEST FORK OF SPA CREEK; THENCE WITH THE HIGH WATER LINE OF THE WESTERN  
33 SIDE OF THE SOUTH FORK OF SPA CREEK TO INTERSECT thence southerly with the  
34 centerline of said south fork to the extended centerline of Pumphouse Road; thence following  
35 the boundary of "Truxtun Heights" PLAT (AS RECORDED AT 10:6) in a clockwise or southerly  
36 then westerly direction to INTERSECT WITH THE SOUTHEASTERN BOUNDARY LINE OF  
37 THE CHATHAM LANE PLAT (AS NOW RECORDED AT 69:38), THENCE IN A  
38 COUNTERCLOCKWISE DIRECTION WITH THE BOUNDARY LINE OF THE CHATHAM LANE  
39 PLAT, NORTHEASTLY, NORTHWESTLY, SOUTHWESTLY, NORTHWESTLY AND  
40 WESTERLY TO INTERSECT THE SOUTHEASTERN BOUNDARY OF TAX MAP 51F,  
41 PARCEL 1318, THENCE WITH SAID BOUNDARY IN A COUNTER CLOCKWISE DIRECTION,  
42 NORTHEASTERLY AND NORTHWESTERLY TO INTERSECT THE SOUTHEASTERN

6 centerline of Greenfield Street; thence continuing in a northeasterly direction following the rear  
7 property lines of addresses #817 through #51 Spa Road; thence with the eastern boundary of  
8 #51 Spa Road in a northerly direction to the centerline of Spa Road; thence in a THENCE IN A  
9 northerly direction to the center of Westgate Circle; thence following the centerline of Taylor  
10 Avenue in a GENERALLY northerly DIRECTION TO INTERSECT THE ABANDONED WB&A  
11 (SOUTH SHORE LINE) RAILROAD BED; THENCE FOLLOWING CENTER LINE OF THE  
12 ABANDONED WB&A (SOUTH SHORE LINE) RAILROAD BED IN A EASTERLY DIRECTION  
13 TO THE POINT OF INTERSECTION WITH THE WESTERN AND SOUTHERN BOUNDARY  
14 LINE OF TAX MAP 51C, PARCEL 437; THENCE WITH THE SOUTHERN BOUNDARY LINE  
15 OF TAX MAP 51C, PARCEL 437, EASTERLY TO INTERSECT THE CENTERLINE OF W.  
16 WASHINGTON STREET; THENCE IN A NORtherly DIRECTION WITH THE CENTERLINE  
17 OF W. WASHINGTON STREET TO INTERSECT THE WESTERN EXTENTION OF THE  
18 NORTHERN BOUNDARY OF PARCEL 379; THENCE WITH THE WESTERN EXTENTION,  
19 THE NORTHERN BOUNDARY LINE OF TAX MAP 51C, PARCEL 379 AND THE EASTERN  
20 EXTENTION OF THE NORTHERN BOUNDARY LINE TO INTERSECT THE CENTERLINE OF

22 CALVERT STREET TO ITS POINT OF INTERSECTION WITH THE CENTERLINE OF THE  
23 NORTHBOUND BLADEN STREET (AKA, ROWE BOULEVARD, BLADEN BOULEVARD);  
24 THENCE IN A NORTHWESTLY DIRECTION WITH THE CENTERLINE OF BLADEN STREET  
25 (AKA, ROWE BOULEVARD, BLADEN BOULEVARD) TO THE POINT OF BEGINNING. and  
26 then westerly direction to the point of beginning.

27 This ward will be known as the Ffirst Wward, but the ward does not include any of the land  
28 contained therein which is the property of the U.S. Naval Academy UNITED STATES  
29 GOVERNMENT OWNED BY THE UNITED STATES GOVERNMENT AND USED BY THE  
30 UNITED STATES DEPARTMENT OF THE NAVY.
