## **2021 Annapolis Election Calendar**

The Board of Supervisor of Elections and the City Clerk have prepared this calendar, for the 2021 Municipal Elections. The reference to the “Code” is to the Charter and Code of the City of Annapolis, not the State Election Code. For the provision in the Code on the computation of time, see the last page of this calendar.

### **Election Cycle**

#### **Wednesday, November 8, 2017 – Tuesday, November 2, 2021**

##### *Code Sec. 4.04.010 Definitions*

“Election cycle” means that period of time beginning on the day after the day of a general election and ending on the day of the next general election.

#### **November 2019**

##### **Friday, November 1, 2019**

- Deadline for being registered to vote in the City for Mayoral Candidates.

##### *Charter, Art. II, Sec. 3(b)*

The mayor must be a registered voter in the city for at least two (2) years immediately preceding the date of the general election.

#### **August 2020**

##### **Monday August 3, 2020**

- Election Office Opens – Accepting Certificates of Candidacy

##### **Code sec. 4.20.030 (G)**

The first date upon which a certificate of candidacy may be obtained and filed is one year prior to the deadline to file a certificate of candidacy.

#### **September 2020**

##### **Monday September 7, 2020**

- Election Office Closed - **Labor Day**, commemorating the American labor movement, the first Monday of September.

### **November 2020**

#### **Monday, November 2, 2020**

- Deadline for being registered to vote in the City for Aldermanic Candidates.

*Charter, Art. II, Sec 3 (c)*

Aldermen, except those first elected from areas annexed to the city, shall be registered voters in the city for at least one (1) year immediately preceding their election.

#### **Wednesday, November 11, 2020**

- Election Office Closed – **Veterans Day**, commemorating the service of all Americans in defense of the nation, November 11th;

#### **Thursday & Friday November 26 & 27, 2020**

Election Office Closed – **Thanksgiving**, celebrating the freedom and bounty within the grasp of all Americans, the fourth Thursday of November.

### **December 2020**

#### **Friday December 25, 2020**

- Election office Closed – **Christmas**, celebrating the birth of Jesus Christ, December 25<sup>th</sup>.

### **January 2021**

#### **Friday, January 1, 2021**

- Election Office Closed - **New Year's Day**, celebrating the advent of a new year, January 1<sup>st</sup>.

#### **Monday, January 18, 2021**

- Election Office Closed – **Martin Luther King Holiday** - Commemorating the cause of human rights, the third Monday in January;

### **February 2021**

**Monday February 15, 2021**

- Election Office Closed - **President's Day**, celebrating the life and accomplishments of all deceased presidents of the United States, the third Monday of February;

**March 2021**

**Thursday, March 25, 2021**

- Election Office Closed – **Maryland Day**, celebrating the founding of the State of Maryland, March 25th;

**April 2021**

**Friday April 2, 2021**

- Election Office Closed – **Good Friday**, commemorating the crucifixion of Jesus Christ, the Friday immediately preceding Easter.

**May 2021**

**Monday, May 3, 2021**

- Deadline for being registered to vote in the ward for Aldermanic Candidates.

*Charter, Art. II, Sec. 3 (c)*

A registered voter in the ward from which they are elected for at least six months and must have resided in that ward for at least six (6) months immediately preceding the date of the general election.

**Monday May 31, 2021**

- Election Office Closed – **Memorial Day**, commemorating those who have given their lives in the defense of our nation, the last Monday of May.

**June 2021**

**Tuesday, June 15, 2021**

- Deadline for changing Polling Places

*Code Sec. 4.08110 B*

Except in emergencies a new polling place may not be designated, nor may the location of an existing polling place be changed, **after the Tuesday which is thirteen weeks prior to any primary election.**

## **July 2021**

### **Monday, July 5, 2021**

- Election Office Closed - **Independence Day**, celebrating the Declaration of Independence and commemorating the American Revolution, July 4.

**Monday, July 26, 2021** - The Board's office will be open from **9:00 A.M. to 9:00 P.M.**

- Deadline for filing Certificate of Candidacy, except for write-in candidates.
- Deadline for filing petition for nomination by petition
- Deadline for Council to Certify Ballot Questions to the Board

#### *Code Sec. 4.40.010 A*

Whenever a proposed Charter amendment or other question is to be submitted for popular approval to the voters of the City or to the voters of any area proposed to be annexed to the City, the City Council shall certify the question to the board on or before the day on which a certificate of candidacy must be filed under this title.

## **August 2021**

### **Monday, August 2, 2021**

- Deadline for Withdrawing as Candidate for Nomination - The Board's office will be open until 4:30 PM.

#### *Code Sec. 4.20.150 B 1*

Whenever any person who has filed a certificate of candidacy for nomination in any primary election, in a writing signed by the person withdrawing, and acknowledged before a notary public or any other person empowered to take oaths, notifies the board within seven days after the filing date established in this chapter that the person desires to withdraw as a candidate for such nomination, the certificate of candidacy shall be void. The name of the person so withdrawing shall not be printed upon the ballots to be used at the primary election. The filing of a valid certificate of withdrawal of candidacy is a final act of withdrawal; and a person who files such a certificate of withdrawal may not reinstate the person's candidacy, unless the time limit for the filing of candidacies has not expired.

### **Monday, August 9, 2021**

- Deadline for Central Committee to fill vacancy resulting from Failure of any Candidate of Party to File

#### *Code Sec. 4.20.040 B*

In case of any vacancy which may exist in respect to a candidate for any officer elected by the voters by reason of there being no candidate of a political party to file for the same in the primary election, the central committee authorized to fill such vacancy shall file the certificate of nomination with the board not later than the fifth day after the date on which candidates may withdraw their candidacy before the primary election.

## **Tuesday, August 10, 2021**

### **Special Meeting Pursuant to City Code Section:**

**Pursuant to Section 4.20.080.E** of the City Code, a primary election is not required to be held or conducted (including mailing of any ballots) in a ward IF there are no contested nominations for Mayor or Alderman and there are no contested elections for a City central committee party office in that ward. The unopposed Alderman candidates are automatically deemed to be nominated for the General Election. The unopposed City central committee party office candidates are automatically deemed to be elected.

The Board May have to have a Special Meeting on or before Monday, August 16, 2021, to vote Pursuant to Section 4.20.080.E

1. Aldermanic Candidates nominated for the General Election.
2. City Central Committee Candidates Elected.

## **Monday, August 16, 2021**

- Deadline for Voter Registration for Primary. The Board's office will be open from 9:00 A.M. to 9:00 P.M.

### *Code Sec. 4.16.040 A*

A person may not vote in a municipal election if the person registers after the fifth Monday preceding the election.

- Deadline for Change of Address or Name, or request for Party Designation or change in Party Affiliation
- Deadline for Applying for Registration List - Reports may be obtained from the AACO Board of Elections Office located at 6740 Baymeadow Drive, Glen Burnie, MD 21061 or by [email @ elections@aacounty.org](mailto:elections@aacounty.org)
- Beginning of period for Posting Ballot for five days of Public Inspection

### *Code Sec. 4.24.070 B*

No less than twenty-five days before any election, the form and arrangement of all ballots to be used in the election, showing the offices, names of candidates, charter amendments and questions, shall be prepared by the board and made available for inspection by any registered voter. Following five days of public display,

a court may not entertain a suit or grant injunctive relief to any party seeking to challenge the form or arrangement of the ballots or the wording of a charter amendment or question on a ballot. If the ballot titles of charter amendments and questions are certified prior to twenty-five days before the election, they shall be made available for inspection by any registered voter.

### **Tuesday, August 24, 2021**

- Deadline for Appointment of Election Judges

*Code Sec. 4.08.050 D.*

The judges shall be appointed not later than the Tuesday which is four weeks prior to any city primary election.

Reporting Period: **11/6/2017 – 8/22/2021**

**For Incumbents** Reporting Period: **6/29/20 – 8/22/2021**

*Code Sec. 4.44.080 a (1)*

The report shall be completed, except as otherwise provided in this section, **through and including the Sunday immediately preceding the day by which that report is to be filed**. The initial report filed shall contain all contributions and loans received and expenditures made since the date of the last preceding election to fill the office for which the person is a candidate. **No later than the fourth Tuesday preceding any primary election.**

### **Friday, August 27, 2021**

- End of Period for Posting Ballot for five days of Public Inspection.
- Deadline for Court to Entertain Suit.

*Code Sec. 4.24.070 B.*

## **September 2021**

### **Wednesday, September 1, 2021**

- Report on Party Registration

*Code Sec. 4.16.050 Reports of Registration.*

Within fifteen days after the commencement of the five-week period before a primary election in which voters already registered are not allowed to affiliate with a party or change party affiliation for purposes of this chapter, the board shall prepare a report of registration setting forth the following information, as shown on the books of the board as of the date of the commencement of the five-week period:

A. The name of each political party with which one or more registered voters in the City are then affiliated.

B. The total number of registered voters affiliated with each such political party.

### **Tuesday, September 14, 2021**

- Deadline for **Second** Campaign Finance Report –

Reporting Period: **8/23/2021 – 9/12/2021**

*Code Sec. 4.44.080 A (2)*

No later than the Tuesday immediately preceding any primary election.

### **Friday, September 17, 2021**

- Deadline for Receipt of Application for Regular Absentee Ballot - The Board's office will be open until 4:30 PM .

*Code Sec. 4.28.010*

A registered voter may vote by absentee ballot. The voter shall make application for an absentee ballot as provided in this chapter. The application shall be filed in the office of the board not later than 4:30 P.M. on the Friday preceding any election. Upon receipt of the application, the board shall provide by mail or other means an absentee ballot to the voter entitled to the ballot.

### **Sunday September 19 & Monday September 20, 2021**

- Publication of Election Notice in Newspaper

*Code Sec. 4.08.090*

Except as otherwise provided by law, the board shall publish, for all elections, for two consecutive days prior to each election, in one or more newspapers of general circulation within the City, the time and place and names of the candidates for nomination, or for members of central committees of a political party. The list of nominations published by the board shall be arranged to the extent practicable, in the order and form



in which they are to be printed upon the ballots. In the discretion of the board, notice may also be given by handbills set up in those public places in each precinct as the board determines.

### **Monday, September 20, 2021**

- Begin Accepting Applications for Emergency Absentee Ballot

#### *Code Sec. 4.28.030 A*

After the Friday preceding an election and on the day of the election prior to the time the polls close, any person registered and otherwise qualified to vote may apply for an emergency absentee ballot if the person is notified after the time for making application for an absentee ballot that, as a condition of employment, the person is required to be absent from the City on the day of an election, if the person is unable to be physically present at the polls as a result of illness or accident occurring after the time of making application for an absentee ballot, or if the person is unable to be present because of a death or serious illness in the person's immediate family occurring after the time for making application.

### **Tuesday, September 21, 2021**

- **Primary Election Day** - The office will be open from 6:00 A.M. to 8:00 P.M.

#### *Code Sec. 4.24.020 Hours for voting.*

The polling places throughout the City shall be opened by the judges at seven a.m. on the day of election and the polling places shall remain open until eight p.m. on the same day, when the polling places shall be closed.

#### *Code Sec. 4.24.190(A)*

The polls shall be officially closed at eight p.m., except that all qualified voters who are then waiting in line to vote shall be permitted to do so by the judges.

#### *Code Sec. 4.08.080 Office hours on certain days.*

The Office of the Election Board shall be open on Election Day no later than seven a.m. and close no earlier than eight p.m., and the members of the board shall be available when needed on such day

- End Accepting Applications for Emergency Absentee Ballot.

#### *Code Sec. 4.28.030 A*

After the Friday preceding an election and on the day of the election prior to the time the polls close, any person registered and otherwise qualified to vote may apply for an emergency absentee ballot if the person is notified after the time for making application for an absentee ballot that, as a condition of employment, the person is required to be absent from the City on the day of an election, if the person is unable to be physically present at the polls as a result of illness or accident occurring after the time of making application for an absentee ballot, or if the person is unable to be present because of a death or serious illness in the person's immediate family occurring after the time for making application.

### **Tuesday, September 21, 2021**

- Deadline for Receipt by Board of Absentee Ballots, including Emergency Absentee Ballots, but Excluding Ballots, which are mailed.

*Code Sec. 4.28.100 C*

Timeliness of absentee ballots:

1. A ballot shall be considered as received timely, provided:
  - a. It has been received by the board prior to the closing of the polls on Election Day; or
  - b. It was mailed on or before Election Day, the United States Postal Service, or postal service of any other country has provided verification of that fact by affixing a mark so indicating on the covering envelope, and the board receives the ballot from the United States Postal Service not later than 10:00 A.M. on the Tuesday following the Election Day.
2. Any ballot not received in accordance with subparagraph 1 above shall not be counted.

**Wednesday, September 22, 2021**

- Board of Canvass conducts Canvass

*Code Sec. 4.32.010 Organization—Oath—Sessions.*

On the next business day following every primary, general or special election, the Board of Elections shall be reconstituted as the Board of Canvassers and shall meet at the office of the Board. The Board of Canvassers shall elect a chair and secretary from their number. Each member of the Board of Canvassers shall recite an oath, under the penalty of perjury, to truly canvass, add up and declare the votes as required by law. The Board of Canvassers has the same powers as the Board of Supervisors of Elections. All questions arising in the course of their proceedings shall be determined by a majority of the canvassers. All the sessions, deliberations and proceedings of the Board of Canvassers shall be public. All candidates and their counsel shall have the right to attend and inspect the original statements and returns, and all other documents and records.

- Deadline for removal of campaign signs by defeated candidates

*Code Sec. 4.48.170 E*

Any election campaign sign which has been erected or posted shall be removed within seven days after the election to which the sign was applicable.

**Wednesday, September 29, 2021**

- Voter Registration Reopens

**Thursday, September 30, 2021 (unless canvass continues beyond September 29, 2021)**

- Deadline for transmitting statement of returns to City Council and Clerk of the Circuit Court.

*Code Sec. 4.32.050 A Certified returns--Transmission for record.*

Within forty-eight hours after the completion of the canvass, the Board of Canvassers shall transmit one of each of the statements made by it, attested by the signature of its chair and secretary, to the City Council and to the Clerk of the Circuit Court for Anne Arundel County, who shall enter the same of record.

## **October 2021**

### **Friday, October 1, 2021**

- Deadline for Declining Nomination. - The Board's office will be open until 4:30 PM .

#### *Code Sec. 4.20.150 C (1)*

(1) Any person nominated for Mayor or Alderman may decline such nomination by notifying the board that the nomination is declined. The statement of declination shall be in writing, signed by the person nominated and acknowledged before a notary public or any person empowered to take oaths, and shall be filed with the board within ten days after the date of the primary election. If the person nominated complies with the provisions of this subdivision for declining nomination, the nomination shall be void; and the name of any person so withdrawing shall not be printed upon the ballots.

- Deadline for Petitioning for Recount in Primary Election

#### *Code Sec. 4.20.190 Recount--Petition deadline.*

Within ten days after the day of any primary election, or within two days after the results of the canvass are declared official, any candidate for a nomination or for member of a central committee who has been defeated on the face of the returns, may petition the board for an appeal from and review of the action and decision of the judges in counting the ballots, and for a re-canvass and recount of the ballots cast in any or all of the precincts of the City.

Note: Should the declaration of the results of the canvass be delayed to within two days of the above deadline or beyond, the deadline for filing a recount petition is within two days of the declaration of the results of the canvass. *Code Sec. 4.20.190.*

- Deadline for filling Vacancy in Nomination

#### *Code Sec. 4.20.160 A*

Vacancies in nomination may be filled by the central committee of the political party to which the nominee belongs. The person filling the vacancy shall satisfy the requirements of Section 4.20.010. In the event of any vacancy occurring because of the declination, disqualification or death of any person nominated, or because of a tie vote in any primary election, except as provided in this section, the vacancy shall be filled at least thirty days before the election. Where the vacancy results from a tie vote, the nominee selected to fill the vacancy shall be one of the candidates receiving the tie vote.

- Beginning of time for public inspection of text of ballot questions (if applicable)

#### *Code Sec. 4.40.080 B*

The complete text of any question shall be made available on the city website for public inspection and shall be available in the office of the board during normal business hours for thirty days preceding the election at which the question is to be voted upon.

### **Monday, October 4, 2021 - General**

- Deadline for Voter Registration. The Board's office will be open from 9:00 A.M. to 9:00 P.M.

#### *Code Sec. 4.16.040 A*

A person may not vote in a municipal election if the person registers after the fifth Monday preceding the election.

#### *Code Sec. 4.08.080 B*

The Offices of the Board shall be opened from nine a.m. to nine p.m. on the fifth Monday prior to any election to provide for voter registration and to receive registration by mail applications. Registrars shall permit all qualified persons who, at the official closing time of nine p.m., are waiting to register to do so.

- Deadline for change of address or name, request for party designation, or change of party affiliation

#### *Code Sec. 4.16.040 B*

A notification of change of address or name, or request for party designation or change in party affiliation, received by the Board of Supervisors of Elections of the County after the fifth Monday preceding a municipal election is not effective for that election.

- Deadline for Application of Voter List

#### *Code Sec. 4.16.090 Copies of registration lists.*

Requests for copies of current registrations shall be referred to Anne Arundel County Election Board of Election Office located at 6740 Baymeadow Drive, Glen Burnie, Maryland 21060 or by [email @ elections@aacounty.org](mailto:elections@aacounty.org)

- Beginning of period for posting ballot for five days of public inspection

#### *Code Sec. 4.24.070 (B)*

No less than twenty-five days before any election, the form and arrangement of all ballots to be used in the election, showing the offices, names of candidates, charter amendments and questions, shall be prepared by the board and made available for inspection by any registered voter. Following five days of public display, a court may not entertain a suit or grant injunctive relief to any party seeking to challenge the form or arrangement of the ballots or the wording of a charter amendment or question on a ballot. If the ballot titles of charter amendments and questions are certified prior to twenty-five days before the election, they shall be made available for inspection by any registered voter.

Following five days of public display, a court may not entertain a suit or grant injunctive relief to any party seeking to challenge the form or arrangement of the ballots or the wording of a charter amendment or question on a ballot. If the ballot titles of charter amendments and questions are certified prior to twenty-five days before the election, they shall be made available for inspection by any registered voter.

*Code Sec. 4.28.040*

Except for persons who become eligible to cast an emergency absentee ballot, a qualified voter desiring to vote at any election as an absentee voter shall make application in writing to the board for an absentee ballot, and the application must be received not later than the close of business Tuesday preceding the election.

*Code Sec. 4.28.010*

A registered voter may vote by absentee ballot. The voter shall make application for an absentee ballot as provided in this chapter. The application shall be filed in the office of the board not later than 4:30 P.M. on the Friday preceding any election. Upon receipt of the application, the board shall provide by mail or other means an absentee ballot to the voter entitled to the ballot.

**October/November 2021****Sunday, October 31, 2021 & Monday November 1, 2021**

- Publication of Election Notice

*Code Sec. 4.08.090*

Except as otherwise provided by law, the board shall publish, for all elections, for two consecutive days prior to each election, in one or more newspapers of general circulation within the City, the time and place and names of the candidates for nomination, or for members of central committees of a political party. The list of nominations published by the board shall be arranged to the extent practicable, in the order and form in which they are to be printed upon the ballots. In the discretion of the board, notice may also be given by handbills set up in those public places in each precinct as the board determines.

*Code Sec. 4.40.080A*

To the extent not otherwise provided by State law, the board shall advertise the title and a concise statement, prepared by the City Attorney, of every question to be submitted for approval of the voters at the same time and in the same manner as is required for the election of candidates at the general election (if applicable).

*Code Sec. 4.28.030 A*

After the Friday preceding an election and on the day of the election prior to the time the polls close, any person registered and otherwise qualified to vote may apply for an emergency absentee ballot if the person is notified after the time for making application for an absentee ballot that, as a condition of employment, the person is required to be absent from the City on the day of an election, if the person is unable to be physically present at the polls as a result of illness or accident occurring after the time of making application for an absentee ballot, or if the person is unable to be present because of a death or serious illness in the person's immediate family occurring after the time for making application.

*Code Sec. 4.28.030 F*

Any emergency absentee ballot received by the board after the time for closing of the polls may not be counted.

**Tuesday, November 2, 2021 - Office will be open from 5:45 A.M. to 9:00 P.M.**

The polling places throughout the City shall be opened by the judges at seven a.m. on the day of election and the polling places shall remain open until eight p.m. on the same day, when the polling places shall be closed.

- End accepting of Applications for Emergency Absentee Ballot

*Code Sec. 4.28.030 F*

Any emergency absentee ballot received by the board after the time for closing of the polls may not be counted.

- Deadline for Receipt by Board of Absentee Ballots, including Emergency Absentee Ballots, but Excluding Ballots which are mailed.

*Code Sec. 4.28.030 A*

  - a. It has been received by the board prior to the closing of the polls on Election Day; or
  - b. It was mailed on or before Election Day, the United States Postal Service, or postal service of any other country has provided verification of that fact by affixing a mark so indicating on the covering envelope, and the board receives the ballot from the United States Postal Service not later than 10:00 A.M. on the Tuesday following the Election Day.
2. Any ballot not received in accordance with subparagraph 1 above shall not be counted.

- End Election Cycle

*Code Sec. 4.04.010*

“Election cycle” means that period of time beginning on the day after the day of a general election and ending on the day of the next general election.

**Wednesday, November 3, 2021**

- Board of Canvassers Conducts Canvass

*Code Sec. 4.32.010 Organization—Oath—Sessions.*

On the next business day following every primary, general or special election, the Board of Elections shall be reconstituted as the Board of Canvassers and shall meet at the office of the Board. The Board of Canvassers shall elect a chair and secretary from their number. Each member of the Board of Canvassers shall recite an oath, under the penalty of perjury, to truly canvass, add up and declare the votes as required by law. The Board of Canvassers has the same powers as the Board of Supervisors of Elections. All questions arising in the course of their proceedings shall be determined by a majority of the canvassers. All the sessions, deliberations and proceedings of the Board of Canvassers shall be public. All candidates and their counsel shall have the right to attend and inspect the original statements and returns, and all other documents and records.

**Tuesday, November 9, 2021**

- Deadline for removal of all campaign signs

*Code Sec. 4.48.170 E*

Any election campaign sign which has been erected or posted shall be removed within seven days after the election to which the sign was applicable.

**Wednesday, November 10, 2021 (unless canvass continues beyond November 9, 2021)**

- Deadline for transmitting statement of returns to City Council and Clerk of the Circuit Court.

*Code Sec. 4.32.050 A*

Within forty-eight hours after the completion of the canvass, the Board of Canvassers shall transmit one of each of the statements made by it, attested by the signature of its chair and secretary, to the City Council and to the clerk of the circuit court for Anne Arundel County, who shall enter the same of record.

- Voter Registration re-opens.

**Thursday, November 11, 2021**

- Election Office Closed – Veterans Day, commemorating the service of all Americans in defense of the nation, November 11th;

**Friday, November 12, 2021**

- Deadline for petitioning for recount

*Code Sec. 4.36.010*

In a general or special election, a recount may be requested in accordance with *Section 4.20.190 and 4.20.200*. A recount in such an election shall be conducted in the manner provided.



Note: Should the declaration of the results of the canvass be delayed to within two days of the above deadline or beyond, the deadline for filing a recount petition is within two days of the declaration of the results of the canvass.

### **Thursday & Friday, November 25 & 26, 2021**

- Election Office Closed – Thanksgiving, celebrating the freedom and bounty within the grasp of all Americans, the fourth Thursday of November.

### **December 2021**

#### **Wednesday, December 1, 2021**

- Deadline for **Fifth** campaign Finance Report –

Reporting Period: **10/25/2021 – 11/2/2021**

*Code Sec. 4.44.080 A (7)*

No later than December 1st following a general election. This report shall cover the balance of the preceding election cycle which ends on the day of the general election.

#### **Monday, December 6, 2021**

- Mayor and Aldermen take oath of office

Charter Sec. 5. - Primary election dates; municipal election dates; term dates.

The mayor and aldermen elected at each municipal election shall qualify in the manner prescribed by Article II, Section 3 of this Charter, and shall take office on the first Monday in December of the year in which they are elected and shall hold office until the first Monday in December in the fourth year following, or until their successors are elected and qualify.

### **July 2022-2024**

#### **July 1, 2022, 2023 & 2024**

- Deadline for Campaign Finance Report **in year in which there is no election.**

*Code Sec. 4.44.080 A (6)*

No later than July 1st in any year in which there is no election for City Council notwithstanding special elections;

The following is the provision from the Annapolis Election Code on the computation of time:

*Code Sec. 4.04.020 Time computation.*

In computing the times of notice to be given, or for the performing of any other act under this title, Saturday, Sunday, or a legal holiday shall be included, except when the day on which notice should be given or an act should be performed occurs on a Saturday, Sunday or legal holiday, in which case the notice shall be given or the act performed on the next regular business day following the Saturday, Sunday or legal holiday. In the computation, the day of giving notice or performing any act and the day of registration or election shall be excluded.
