Permit holders agree to abide by all rules, regulations and laws governing the use of the Annapolis City Harbor, Truxtun Park, and any related parking areas and launch facilities. **No commercial activity is permitted at the Boat Ramp.** "Commercial activity" includes, but it not limited to, operation of charter vessel services, solicitation for charter services, sale of food, goods or services, product or service advertising or promotion, or any activity conducted to make a profit. **Violators are subject to ticketing and towing of vehicles, trailers, vessels, and/or permits may be revoked.**

**Any** permit issued by the Harbormaster becomes valid the day it is issued and will **expire on December 31<sup>st</sup>** of that same year. Lost permits will not be re-issued, and a new permit must be purchased or daily launch fee paid for continued use.
