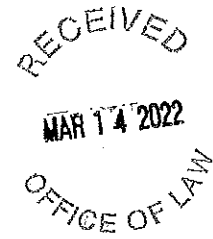

Below is an outline of items related to this final report.

- MailChimp expense on 11/12/21 was for email list fee that was incurred before Election Day, but billed after Election Day. Added as an obligation at the guidance of City Election office so appears as a distribution on this report.
- Bank account documentation shows a zero balance but campaign reporting indicates funds still available. With the merger of Severn Bank and Shore United Banks plus the timing of closing out this campaign and emptying the account of funds by March 14, 2022, the account balance and report balance do not, at this time, reconcile. We no longer have access to the account to find the discrepancy since the account was closed on March 10, 2022. We are in the process of getting the information to balance the report with the banking statements. We have been informed this will take time based on the merger.
