# 2017 Annapolis Election Calendar

This calendar has been prepared by the City Clerk for the 2017 Municipal Election. The reference to the "Code" is to the Charter and Code of the City of Annapolis, not the State Election Code. For the provision in the Code on the computation of time, see the last page of this calendar.

## **Election Cycle**

#### Wednesday, November 6, 2013 - Tuesday, November 7, 2017

Code Sec. 4.04.010 Definitions

"Election cycle" means that period of time beginning on the day after the day of a general election and ending on the day of the next general election.

## November 2015

# Monday, November 9, 2015

Deadline for being registered to vote in the City for mayoralty candidates.

Charter, Art. II, Sec. 3(b)

The mayor must be a registered voter in the city for at least two (2) years immediately preceding the date of the general election. A person may not hold office as mayor for more than two (2) full consecutive terms to which elected in the manner provided by City Code.

Note: The provision in the Code in computing time applies only to the Code and not to the Charter. See Code Sec. 4.04.020

## Monday August 1, 2016

Election office open – begin accepting certificates of candidacy

The first date upon which a certificate of candidacy may be obtained and filed is one year prior to the deadline to file a certificate of candidacy, as described below in paragraph H.

Except for certificates of candidacy filed by write-in candidates and as otherwise provided in this chapter, a certificate of candidacy filed under oath shall be received by the board not later than nine p.m. On the Monday which is seven weeks before the day on which the primary election should be held under the primary election law. If the filing date should occur on a legal holiday, then a certificate of candidacy shall be received by the board not later than nine p.m. On the next regular business day which is not a legal holiday.

Code Sec. 4.20.090 B

A candidate for public office seeking nomination by petition shall file a certificate of candidacy at the time and place and in the manner provided in this chapter and shall comply with all other applicable provisions of this title, in the same manner as candidates for nomination at a primary election.

Whenever a proposed Charter amendment or other question is to be submitted for popular approval to the voters of the City or to the voters of any area proposed to be annexed to the City, the City Council shall certify the question to the board on or before the day on which a certificate of candidacy must be filed under this title.

## August 2017

## Monday, August 7, 2017

• Deadline for withdrawing as candidate for nomination

Code Sec. 4.20.150 B 1

Whenever any person who has filed a certificate of candidacy for nomination in any primary election, in a writing signed by the person withdrawing, and acknowledged before a notary public or any other person empowered to take oaths, notifies the board within seven days after the filing date established in this chapter that the person desires to withdraw as a candidate for such nomination, the certificate of candidacy shall be void. The name of the person so withdrawing shall not be printed upon the ballots to be used at the primary election. The filing of a valid certificate of withdrawal of candidacy is a final act of withdrawal; and a person who files such a certificate of withdrawal may not reinstate the person's candidacy, unless the time limit for the filing of candidacies has not expired.

Code Sec. 4.20.150 B 2

A certificate of withdrawal of candidacy shall be accepted until four-thirty on the last day for withdrawing.

# Monday, August 14, 2017

Deadline for central committee to fill vacancy resulting from failure of any candidate of party to file

Code Sec. 4.20.040 B

In case of any vacancy which may exist in respect to a candidate for any officer elected by the voters by reason of there being no candidate of a political party to file for the same in the primary election, the central committee authorized to fill such vacancy shall file the certificate of nomination with the board not later than the fifth day after the date on which candidates may withdraw their candidacy before the primary election.

#### Monday, August 21, 2017

• Deadline for voter registration for primary. The Board's office will be open from 9:00 A.M. to 9:00 P.M.

• Deadline for appointment of election judges

The judges shall be appointed not later than the Tuesday which is four weeks prior to any city primary election. Unless excused for good cause by the board, they shall be bound to serve in the position until the Tuesday which is four weeks prior to the next city primary election.

# Tuesday, August 22, 2017

Deadline for first campaign finance report

Code Sec. 4.44.080 A(1)

A candidate to public or party office, and the treasurer designated by that candidate shall file and sign the report or statement of contributions, loans and expenditures as prescribed in accordance with this chapter with the board. Election reports as specified below are required by all candidates for public or party office, whether or not the candidate's name appears on the primary ballot, the candidate withdraws subsequent to filing the candidate's certificate of candidacy or the candidate is unsuccessful in the election. Each report filed shall contain all contributions received and expenditures made in furtherance of the candidate's nomination or election by the candidate personally or, with the knowledge of the candidate, by any other person or groups of persons. The report shall be completed, except as otherwise provided in this section, through and including the Sunday immediately preceding the day by which that report is to be filed. The initial report filed shall contain all contributions and loans received and expenditures made since the date of the last preceding election to fill the office for which the person is a candidate. Each subsequent report shall contain all contributions and loans received and expenditures made since the end of the period for which the last preceding report was filed. A statement to that effect must be included on the forms prescribed pursuant to this chapter. The reports shall be filed as follows:

1. No later than the fourth Tuesday preceding any primary election;

Deadline of period for posting ballot for five days of public inspection

Code Sec. 4.24.070 B

No less than twenty-five days before any election, the form and arrangement of all ballots to be used in the election, showing the offices, names of candidates, charter amendments and questions, shall be prepared by the board and made available for inspection by any registered voter. Following five days of public display, a court may not entertain a suit

or grant injunctive relief to any party seeking to challenge the form or arrangement of the ballots or the wording of a charter amendment or question on a ballot. Following five days of public display, a court may not entertain a suit or grant injunctive relief to any party seeking to challenge the form or arrangement of the ballots or the wording of a charter amendment or question on a ballot. If the ballot titles of charter amendments and questions are certified prior to twenty-five days before the election, they shall be made available for inspection by any registered voter.

# Wednesday, August 30, 2017

Report on party registration

Code Sec. 4.16.050 Reports of Registration.

Within fifteen days after the commencement of the five-week period before a primary election in which voters already registered are not allowed to affiliate with a party or change party affiliation for purposes of this chapter, the board shall prepare a report of registration setting forth the following information, as shown on the books of the board as of the date of the commencement of the five-week period:

- A. The name of each political party with which one or more registered voters in the City are then affiliated; and
- B. The total number of registered voters affiliated with each such political party.

## Sunday September 17 & Monday September 18, 2017

Except as otherwise provided by law, the board shall publish, for all elections, for two consecutive days prior to each election, in one or more newspapers of general circulation within the City, the time and place and names of the candidates for nomination, or for members of central committees of a political party. The list of nominations published by the board shall be arranged to the extent practicable, in the order and form in which they are to be printed upon the ballots. In the discretion of the board, notice may also be given by handbills set up in those public places in each precinct as the board determines.

#### Monday, September 18, 2017

• Begin accepting applications for emergency absentee ballot

Code Sec. 4.28.030 A

After the Friday preceding an election and on the day of the election prior to the time the polls close, any person registered and otherwise qualified to vote may apply for an emergency absentee ballot if the person is notified after the time for making application for an absentee ballot that, as a condition of employment, the person is required to be absent from the City on the day of an election, if the person is unable to be physically present at the polls as a result of illness or accident occurring after the time of making application for an absentee ballot, or if the person is unable to be present because of a death or serious illness in the person's immediate family occurring after the time for making application.

## Tuesday, September 19, 2017

End accepting applications for emergency absentee ballot

Code Sec. 4.28.030 A

After the Friday preceding an election and on the day of the election prior to the time the polls close, any person registered and otherwise qualified to vote may apply for an emergency absentee ballot if the person is notified after the time for making application for an absentee ballot that, as a condition of employment, the person is required to be absent from the City on the day of an election, if the person is unable to be physically present at the polls as a result of illness or accident occurring after the time of making application for an absentee ballot, or if the person is unable to be present because of a death or serious illness in the person's immediate family occurring after the time for making application.

#### Tuesday, September 19, 2017

The polling places throughout the City shall be opened by the judges at seven a.m. on the day of election and the polling places shall remain open until eight p.m. on the same day, when the polling places shall be closed.

After the Friday preceding an election and on the day of the election prior to the time the polls close, any person registered and otherwise qualified to vote may apply for an emergency absentee ballot if the person is notified after the time for making application for an absentee ballot that, as a condition of employment, the person is required to be absent from the City on the day of an election, if the person is unable to be physically present at the polls as a result of illness or accident occurring after the time of making application for an absentee ballot, or if the person is unable to be present because of a death or serious illness in the person's immediate family occurring after the time for making application.

Code Sec. 4.28.100 C (1)

A ballot shall be considered as received timely, provided:

- a. It has been received by the board prior to the closing of the polls on Election Day; or
- b. It was mailed before Election Day, the United States Postal Service, or postal service of any other country has provided verification of that fact by affixing a mark so indicating on the covering envelope, and the board receives the ballot from the United States Postal Service not later than the close of business on the Wednesday following election day.

## Wednesday, September 20, 2017

Deadline for receipt by the Board of absentee ballots which have been mailed by the day before the election

Code Sec. 4.28.100 C (1 b)

Timeliness of absentee ballots:

- 1. A ballot shall be considered as received timely, provided:
- a. It has been received by the board prior to the closing of the polls on Election Day; or
- b. It was mailed before Election Day, the United States Postal Service, or postal service of any other country has provided verification of that fact by affixing a mark so indicating on the covering envelope, and the board receives the ballot from the United States Postal Service not later than the close of business on the Wednesday following election day.

#### Tuesday, September 26, 2017

Board of Canvass conducts canvass

Code Sec. 4.32.010 Organization—Oath—Sessions.

On the Tuesday following every primary, general or special election, the Board of Elections shall be reconstituted as the Board of Canvassers and shall meet at the office of the Board. The Board of Canvassers shall elect a chair and secretary from their number. Each member of the Board of Canvassers shall recite an oath, under the penalty of perjury, to truly canvass, add up and declare the votes as required by law. powers as the Board of Supervisors of Elections. All questions arising in the course of their proceedings shall be determined by a majority of the canvassers. All the sessions, deliberations and proceedings of the Board of Canvassers shall be public. All candidates and their counsel shall have the right to attend and inspect the original statements and returns, and all other documents and records.

Deadline for removal of campaign signs by defeated candidates

Code Sec. 4.48.170 E

Any election campaign sign which has been erected or posted shall be removed within seven days after the election to which the sign was applicable.

## Thursday, September 28, 2017 (unless canvass continues beyond one day)

Deadline for transmitting statement of returns to City Council and Clerk of the Circuit Court.

Code Sec. 4.32.050 A Certified returns--Transmission for record.

Within forty-eight hours after the completion of the canvass, the Board of Canvassers shall transmit one of each of the statements made by it, attested by the signature of its chair and secretary, to the City Council and to the Clerk of the Circuit Court for Anne Arundel County, who shall enter the same of record.

## Friday, September 29, 2017(unless canvass continues beyond one day)

Deadline for declining nomination.

Code Sec. 4.20.150 C (1) and (2)

- (1) Any person nominated for Mayor or Alderman may decline such nomination by notifying the board that the nomination is declined. The statement of declination shall be in writing, signed by the person nominated and acknowledged before a notary public or any person empowered to take oaths, and shall be filed with the board within ten days after the date of the primary election. If the person nominated complies with the provisions of this subdivision for declining nomination, the nomination shall be void; and the name of any person so withdrawing shall not be printed upon the ballots.
- (2) A certificate of declination of candidacy shall be accepted until four-thirty p.m., on the last day for declining.

#### Friday, September 29, 2017

• Deadline for petitioning for recount in primary election

Code Sec. 4.20.190 Recount--Petition deadline.

Within ten days after the day of any primary election, or within two days after the results of the canvass are declared official, any candidate for a nomination or for member of a central committee who has been defeated on the face of the returns, may petition the board for an appeal from and review of the action and decision of the judges in counting the ballots, and for a re-canvass and recount of the ballots cast in any or all of the precincts of the City.

Note: Should the declaration of the results of the canvass be delayed to within two days of the above deadline or beyond, the deadline for filing a recount petition is within two days of the declaration of the results of the canvass. *Code Sec.* 4.20.190.

Except as otherwise provided by law, the board shall publish, for all elections, for two consecutive days prior to each election, in one or more newspapers of general circulation within the City, the time and place and names of the candidates for nomination, or for members of central committees of a political party. The list of nominations published by the board shall be arranged to the extent practicable, in the order and form in which they are to be printed upon the ballots. In the discretion of the board, notice may also be given by handbills set up in those public places in each precinct as the board determines.

To the extent not otherwise provided by State law, the board shall advertise the title and a concise statement, prepared by the City Attorney, of every question to be submitted for approval of the voters at the same time and in the same manner as is required for the election of candidates at the general election (if applicable).

Each member of the Board of Canvassers shall recite an oath, under the penalty of perjury, to truly canvass, add up and declare the votes as required by law. The Board of Canvassers has the same powers as the Board of Supervisors of Elections. All questions arising in the course of their proceedings shall be determined by a majority of the canvassers. All the sessions, deliberations and proceedings of the Board of Canvassers shall be public. All candidates and their counsel shall have the right to attend and inspect the original statements and returns, and all other documents and records.

The mayor and aldermen elected at each municipal election shall qualify in the manner prescribed by Article II, Section 3 of this Charter, and shall take office on the first Monday in December of the year in which they are elected and shall hold office until the first Monday in December in the fourth year following, or until their successors are elected and qualify.

In computing the times of notice to be given, or for the performing of any other act under this title, Saturday, Sunday, or a legal holiday shall be included, except when the day on which notice should be given or an act should be performed occurs on a Saturday, Sunday or legal holiday, in which case the notice shall be given or the act performed on the next regular business day following the Saturday, Sunday or legal holiday. In the computation, the day of giving notice or performing any act and the day of registration or election shall be excluded.
