**GENERAL INFORMATION**

1. All fees are NON-REFUNDABLE unless the permit application has been DENIED by the City.
2. The permits counter is open 8:30 a.m. to 4:00 p.m., Monday through Friday.
3. **All applications for electrical permits shall require the property tax ID number of the job site.**
4. All checks shall be made payable to CITY OF ANNAPOLIS.
5. All checks returned for non-sufficient funds will result in a STOP WORK ORDER, VOIDING OF PERMIT, and a charge by the City.
6. **RE-INSPECTION FEE - \$100.00-\$250.00** (if assessed) must be paid before another inspection is made.
7. If ever any work for which a permit is required under this code has been commenced without authorization of such permit, a special investigation shall be made before a permit may be issued for such work. In addition to the regular permit fee or any penalty fees, an investigation fee shall be collected.

**CONSTRUCTION ONLY :New Single Family**

(PLUS \$8.00/100 amps or fraction of 100 amps in excess of 200 amps)	

*New Apartment Dwellings*.....80% of fee for a single family dwelling unit

**FLAT RATE FOR NEW NON-RESIDENTIAL**

**CONSTRUCTION ONLY:** (According to size of service equipment of entire building):

200 amps or less.....	175.00
More than 200, less than 300 amps.....	225.00
More than 300, less than 400.....	250.00
More than 400, less than 1200 amps.....	250.00 +
(PLUS \$.75 for each amp in excess of 400 amps)	
More than 1,200 amps.....	1,250.00
+ PLUS 2.50/amp over 1200 amps)	

**Modular homes or pre-fabricated structures must bear a sticker of approval from the U.S. federal govt., the state, a national testing facility, or other recognized inspection bureau. When this sticker is evident,**

**ADDITIONS, ALTERATIONS, REPAIRS TO EXISTING STRUCTURES OR SERVICES:**

**Rough Wiring - (Includes switches, receptacles, wiring controls for burner, windows units)** If the total permit fee above exceeds the comparable fee for a new building as in the preceding flat rate fees, the electrician may apply the lesser fee.

1 to 10 outlets.....	25.00
11 to 40 outlets.....	50.00
