**Easement – Access  
 Deed of Easement and Agreement**

**THIS DEED OF EASEMENT AND AGREEMENT** (the “Easement Agreement”) is made this \_\_\_\_ day of \_\_\_\_\_, 20\_\_ by and between \_\_\_\_\_ (the “Grantor”), and the CITY OF ANNAPOLIS, a municipal corporation of the State of Maryland (the “Grantee”).

WHEREAS, the Grantor is the fee simple title owner of certain real property as further described herein (the “Property”).

WHEREAS, the Grantee desires to enter on, through, and across the land hereinafter described (the “Easement Area”), said Easement Area being a portion of the Property, for the purpose of ingress and egress and other governmental purposes to be in, on, through and across the Easement Area, and the Grantor is willing to grant such right.

NOW, THEREFORE, in consideration of the premises and the sum of One Dollar (\$1.00), the receipt and sufficiency of which is hereby acknowledged, the said Grantor hereby grants and conveys unto the Grantee, a municipal corporation of the State of Maryland, its successors, legal representatives, and assigns, an easement on, over, under, along, across and through that part of the land of the Grantor situate in Anne Arundel County, State of Maryland, as shown in Exhibit A, attached hereto and incorporated herein, for the purpose of ingress and egress and other governmental purposes related thereto.

BEING a portion of the Property at \_\_\_\_\_, Annapolis, Maryland \_\_\_\_\_, which by deed dated \_\_\_\_\_, \_\_\_\_\_, and recorded among the land records of Anne Arundel County, Maryland in liber \_\_\_\_\_, folio \_\_\_\_\_ was granted and conveyed by \_\_\_\_\_ unto the Grantor herein; and

AND the Grantor does hereby agree that this Easement Agreement shall entitle the Grantee, its employees, agents and contractors, and its successors and/or assigns, from time to time and at reasonable times and in a reasonable manner to enter into the Property and upon the Easement Area, whenever it may be necessary for legal governmental purposes relative to the Easement Area provided, however, that the ground hereinabove described shall be restored and left in reasonable condition; and it is further agreed that no buildings, fences or similar structures of any kind shall be erected in, on, over, or around the said Easement Area by the Grantor, the Grantor’s personal representatives, successors and/or assigns; nor shall the existing grade be changed without prior approval of the City of Annapolis Department of Public Works.

1. This Easement Agreement shall be governed by and construed in accordance with the laws of the State of Maryland. The venue for all actions initiated pursuant to this Easement Agreement shall be the Courts of Anne Arundel County, Maryland. The parties hereby waive jury trial in all actions initiated pursuant to this Easement Agreement.

2. This Easement Agreement is the parties’ final and entire understanding and agreement pertaining to the matters set forth herein. There are no representations, conditions, or terms pertaining to these matters, oral or written, other than those expressly set forth herein. This Easement Agreement shall not be amended or modified except in writing signed by the authorized representatives of the parties and duly notarized.

3. This Easement Agreement shall be recorded among the Land Records of Anne Arundel County, Maryland at the Grantee’s expense.

4. The Grantee's use of the Easement Area pursuant to this Easement Agreement, and all terms and conditions set forth herein, shall run with the Property and be binding on and enforceable against the parties and their respective successors and assigns.
